Period of appointment	1 October 2024 for two years. College lectureships of this type are not intended as full-time posts and will often be most suitable for doctoral students in the final stages of their degree or early career academics holding other posts who are seeking additional teaching experience.
Duties	<p>You will be involved in the teaching, academic administration and pastoral care of Pembroke's Law students. This will include:</p> <ul style="list-style-type: none"><li>• Organising and delivering the teaching of Pembroke College undergraduates for four hours (unweighted) per week, during term time and averaged across the year, under the direction of Professors Williams and Ezrachi</li><li>• Setting and marking Collections (internal College exams) to a deadline in 2nd week of term.</li><li>• Writing end of term reports on the performance of your undergraduates using the web-based system (TMS).</li><li>• Liaising as required with other Fellows and Lecturers in the subject and relevant Joint Schools, as regards the teaching of your undergraduates and with other College staff about addressing any pastoral problems which may arise amongst your students.</li><li>• Participating in termly student review meetings and attending the Master's Academic Review for undergraduates in your subject.</li><li>• Participating in the annual undergraduate admissions exercise.</li><li>• Taking part in the College's open days and any other access activities in your subject area.</li><li>• Attending College events for undergraduates and graduates and entertaining the students in your subject as organised within that subject.</li></ul>

	You will also be required to be actively engaged in research and to participate in a career development plan with the support of the college.
Salary	The stipend will be in the range £10,162-£11,322 per annum, according to experience and qualifications. All salary and stipend figures are 2023-24 rates and are subject to annual uplift.

The Master is The Rt Hon Sir Ernest Ryder, formerly Senior President of Tribunals and a Lord Justice of Appeal.</p> <p>The College has an undergraduate body of about 350, around 200 graduates, and 30 Visiting Students. The College admits between 5 and 7 undergraduates a year to read Law (Jurisprudence), including students on the Law with Law Studies in Europe course and 2<sup>nd</sup> BA students.</p>
