### **Frank Abumere**

Dr. Frank Aragbonfoh Abumere is the 2021-23 [Zuzana Simoniova Cmelikova Visiting International Scholar](#) at the Jepson School of Leadership Studies at the University of Richmond. A philosopher and political scientist, he specializes in ethics, political philosophy/political theory, international politics, and African/Africana Studies. He is currently an adjunct professor at Arrupe Jesuit University in Harare, Zimbabwe.

His latest book publications include "African Identities and International Politics" (Routledge, 2022), "Normativity in African Regional Relations" (Rowman & Littlefield, 2022), "Migration from Nigeria and the Future of Global Security" (Palgrave Macmillan, 2022), and "Global Justice and Resource Curse: Combining Statism and Cosmopolitanism" (Routledge, 2021).

Previously, Abumere was a visiting professor at the Centre for Studies in Ethics and Politics, Vita-Salute San Raffaele University in Milan, Italy. Prior to visiting San Raffaele University, he was a senior member of St. Antony's College, University of Oxford; an academic visitor at African Studies Centre, Oxford School of Global and Area Studies, University of Oxford; and a visiting research fellow at the Department of International History, London School of Economics and Political Science. A native of Nigeria, he was also the leader of the Developing World/Global South research unit of the Globalizing Minority Rights Research Group at the Department of Philosophy, The Arctic University of Norway, and a lecturer and assistant professor at the Department of Philosophy, Ebonyi State University, Nigeria.



### **Neta Crawford**

**Neta Crawford** is Montague Burton Chair in International Relations and also holds a Professorial Fellowship at Balliol College.

Her research focuses on war, ethics, normative change, emotions in world politics, and climate change. Neta was elected a member of the American Academy of Arts & Sciences in 2023. She received the Distinguished Scholar award from the International Ethics section of the **International Studies Association** in 2018.

She was a co-winner of the 2003 American Political Science Association Jervis and Schroeder Award for best book in International History and Politics for her book *Argument and Change in World Politics: Ethics, Decolonization, Humanitarian Intervention* (CUP, 2002).

Crawford is a co-founder and co-director of the Costs of War Project, based at Brown University.

Dan Seng Lawn is a passionate researcher, lecturer, and an engaging political analyst and consultant with insightful first-hand knowledge of Myanmar politics in general and Kachin State Politics, in particular, following its political reform process closely by participating in the negotiation process between Ethnic Armed Organizations and the successive Governments.
